### **Treasurer's Report:**

# **Executive Director's Report:**

#### **Progress Report:**

Mrs. Nugent referred to the Progress Report and presented the highlights:

- AT&T Cell Site Lease Bid The draft bid comments provided by the Authority Attorney, Staff and Legal Committee were submitted to the Authority Cellular Antenna Consultants. The final bid specification is anticipated soon.
- Low Voltage Meter(s) The Authority has had discussions with JCP&L regarding the installation of the low voltage meter(s).
- Treatment Plant Sewer Line Replacement This project is in progress and is anticipated to go out for quote soon.
- Town Hall Water Treatment The Authority recently presented a proposal to Town Hall for a shared service agreement regarding oversight of the Town Hall complex water facility. Town Hall contacted the Authority to discuss options related to bringing the public water system to the Town Hall/Public Works complex. The Board provided instructions for the Engineering Committee, Staff and Professionals to meet with the Town Hall representatives to discuss the options.
- F-450 Crane Truck –The F-450 truck that is due to arrive in late fall will be displayed at the New Jersey State League of Municipalities (NJSLOM).
- Water Quality Accountability Act CME has initiated the application process for the New Jersey Environmental Infrastructure Trust (NJEIT) funding with 100% principal forgiveness.
- Inspections Passed the Worker's Comp audit, Township Fire and NJUAJIF inspections. The Authority is in compliance with the NJUAJIF recommendations. The Authority trucks were inspected and all approved as compliant with the proper safety equipment by the Berkeley Township Traffic & Safety Division.
- Electronic Municipal Market Access (EMMA) Disclosure The annual disclosure statement was issued as required and posted on EMMA which is an information board that is open to public domain.
- 2019 Budget In preparation requests for projects or purchases may be submitted by Board Members at this time.

# Well #4 Project:

Phase II – Production Well

Mr. Gemmell stated the Well #4 project is progressing. The façade of the building is almost complete. Most of the mechanical work inside the building is complete. The work in the treatment plant associated with the project is also complete.

Mr. Gemmell stated JCP&L will set the pole in late September. The electric and internet service should be installed in October.
