Motion to approve the Public Meeting Hearing Minutes from the meeting on 05/26/22: Samuel Cammarato, second, Richard Elliott.

#### Treasurer's Report:

Mr. Samuel Cammarato stated for the nine week period (05/28/22-07/29/22) the payroll expenses totaled \$128,070.56 and the operational expenses totaled \$136,963.31.

Samuel Cammarato and Edward Cammarato reviewed the first three weeks. Samuel Cammarato and Fred Bekiarian reviewed the next four weeks. Samuel Cammarato and Edward Cammarato reviewed the last two weeks.

#### **Executive Director's Report:**

## Austin Final Acceptance (5sfhs/Woodhaven SE):

Mrs. Nugent requested of the Board authorization for final acceptance of the Austin – Hayfield Holdings project which added water main to service five single family homes located on Woodhaven Blvd SE. The project was reviewed and recommended for final acceptance and release the performance bond. The release of the performance bond will take place after the posting and review of the maintenance bond which is in the amount of \$7,456.80.

Motion to authorize final acceptance of the Austin project and release of the performance bond after acceptance of the maintenance bond: Richard Elliott, second, Jerome Bollettieri. The motion was approved by voice vote. There were no "nay" votes. Motion Carried.

## Berkeley Terrace Final Approval (performance bond request):

Mrs. Nugent requested of the Board authorization for final approval for the Dream Homes - Berkeley Terrace project which consists of 70 condominiums. The project was reviewed and recommended for final approval. The posting of a performance bond is required by the Authority's Rules and Regulations. The amount of \$562,581.00 with 10% of this money is to be posted in cash and 90% to be posted as a surety bond. Dream Homes is requesting 100% to be posted as a surety bond. Mrs. Nugent requested guidance from the Board regarding this matter. The Board denied this request, but gave authorization for final approval.

Motion to authorize final approval for the Berkeley – Terrace Dream Homes project (with 10% cash portion posted - 90% surety bond): Samuel Cammarato, second, Jerome Bollettieri. The motion was approved by voice vote. Richard Elliott recused.

#### Authorize Ocean First Positive Pay Agreement:

Mrs. Nugent requested of the Board authorization to execute the Positive Pay Agreement with Ocean First Bank. Positive Pay is an automated cash management service used by the bank to deter check fraud and is a requirement of the New Jersey Utility Authorities Joint Insurance Fund (NJUAJIF).

Motion to authorize the Ocean First Positive Pay Agreement: Samuel Cammarato, second, Jerome Bollettieri. The motion was approved by voice vote. There were no "nay" votes. Motion Carried.

Mrs. Nugent referred to the Progress Report and presented the highlights:

- 2009 Ford F250 Utility Box The Township installed the new motor in the F250 Utility Box truck. Is now operational.
- Verizon Station Road Bid The Verizon cellular tenant lease is expiring. The bid packet was advertised and will be accepted on 08/09/22. The bid includes an annual minimum rent of \$45,000.00.
- Meter Bid One bid from Core & Main was received today (07/28/22) at \$138,170.00.
- NJ League of Municipalities Conference November 15-17, 2022.
- Health Benefits Premiums for 2023 A 21.6% increase for health state benefits is anticipated. The Authority's Authorized Health Broker will investigate/compare alternatives to state health benefits program.

• Dental Insurance for 2023 – The Authority's Authorized Health Broker will investigate/compare alternatives.
