#### RESOLUTION OF THE

BERKELEY TOWNSHIP MUNICIPAL UTILITIES AUTHORITY, TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NJ, AUTHORIZING THE WAIVER OF A 10% CASH PORTION OF THE PERFORMANCE BOND FOR THE PROJECT KNOWN AS PINEWALD ESTATES, BLOCK 596, LOTS 1-12, 15-19 & 32; BLOCK 573, LOTS 9, 24-29 & 34-44

WHEREAS, the Berkeley Township Municipal Utilities Authority hereinafter referred to as the Authority had previously granted tentative and final water application approval to Pinewald Estates for the construction of water mains and associated services for six (6) proposed single family dwellings and twelve (12) existing single family dwellings located in the referenced Block and Lots set forth in the caption of this Resolution; and

# RESOLUTION OF THE BERKELEY TOWNSHIP MUNICIPAL UTILITIES AUTHORITY, TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NJ, GRANTING PRELIMINARY, TENTATIVE AND FINAL WATER APPLICATION APPROVAL TO RIVERBAY LANDINGS, BLOCK 956, LOT 4

WHEREAS, the Berkeley Township Municipal Utilities Authority hereinafter referred to as the Authority has received an application for preliminary, tentative and final water application approval for the property set forth above as designated on the official tax map of the Township of Berkeley; and

WHEREAS, the Applicant for the project is Riverbay Landings; and

WHEREAS, the Applicant is proposing to construct eighty (80) garden apartments comprising of ten (10) 2-story eight (8) unit garden apartment buildings on the subject premises; and

WHEREAS, the Consulting Engineer in the referenced review letter has recommended that the Authority approve Riverbay Landings' application for preliminary, tentative and final water application approval subject to compliance with the terms and conditions set forth therein; and

WHEREAS, it appears that the Applicant by complying with all of the conditions set forth in the May 23, 2016 review letter by the Authority's Consulting Engineer is in compliance with the Authority's Rules and Regulations;
