WHEREAS, the Authority pursuant to Agreement is to deduct a 2% retainage or a total of \$8,185.83; and

WHEREAS, the Authority's engineer has reviewed the voucher and supporting documentation and has approved payment to P&A;

NOW THEREFORE BE IT RESOLVED this 22nd day of September, 2016, by the Berkeley Township Municipal Utilities Authority, County of Ocean, State of New Jersey, as follows:

1. The Authority accepts the recommendation of its engineer, CME Associates, with regard to their review of an invoice that was provided for work done on the above-referenced project from August 10, 2016 through August 26, 2016.

2. The Authority authorizes the payment to P&A Construction, Inc., of \$401,105.61 which represents the net amount due from the original invoice of \$409,291.44, less a 2% retainage of \$8,185.83.
