WHEREAS, by Resolution No. 25-2016, dated the 24th day of March, 2016, the Berkeley Township Municipal Utilities Authority ("Authority") amended its Employee Manual to adopt pay scale guidelines for its Operational Staff for the years 2016 through 2019 as well as its Administrative Staff for the years 2016 through 2019; and

WHEREAS, the Authority and its Personnel Committee have deemed it appropriate to modify the pay scale guidelines as referenced in that Resolution;

- 1. In addition to the currently scheduled increase in pay of 2.75% as set forth in Resolution 25-2016, there shall be an additional increase of \$1.45 per hour to all Operational Staff employees for a total of \$3,016.00 for the calendar year 2018.
- 2. In addition to the currently scheduled increase in pay of 2.75% as set forth in Resolution 25-2016, there shall be an additional increase of \$1.45 per hour to all Administrative Staff employees for a total of \$3,016.00 for the calendar year 2018.
- 3. The increase in pay to the Operational Staff and Administrative Staff as set forth herein shall be on a one-time basis and shall be added to their hourly pay and the subsequent increases called for by the pay scale guidelines of 2.75% shall be calculated on the increased hourly rate.

4. All employees shall review the foregoing revisions to the Employee Manual and execute a statement indicating that they have read and understand the contents of the Employee Manual and its aforesaid revisions which statements shall be placed in their personnel files.
