RESOLUTION OF THE BERKELEY TOWNSHIP MUNICIPAL UTILITIES AUTHORITY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE RELEASE OF A PERFORMANCE BOND FOR DOLLAR GENERAL PROJECT, BLOCK 956, LOT 7

WHEREAS, by Resolution, dated May 25, 2017, the Berkeley Township Municipal Utilities Authority (hereinafter referred to as the "Authority") required that a performance bond be posted with the Authority for the work to be done on the referenced project; and

WHEREAS, the Authority has received a request from the developer to release the performance guarantees posted in conjunction with said project; and

WHEREAS, the Authority Engineer has reviewed the project files and made site observations indicating that the work associated with the project has been completed; and

WHEREAS, the Authority Engineer has recommended a release of the performance guarantees associated with the project:

NOW, THEREFORE, BE IT RESOLVED, this 22nd day of March, 2018, by the Berkeley Township Municipal Utilities Authority, County of Ocean, State of New Jersey, as follows:

- The Authority hereby authorizes the release of the performance bond previously
 posted with the Authority to ensure completion of the improvements associated
 with this project.
- 2. This release is subject to the posting of a maintenance guarantee in the amount of 15% of the cost of improvements or \$2,725.38 for a period of two (2) years from the date of this Resolution.

3. The Authority hereby authorizes and directs the Chairperson, Secretary,

Executive Director and Authority Attorney to execute any and all necessary

documents in order to implement the intent of this Resolution.
