# RESOLUTION OF THE BERKELEY TOWNSHIP MUNICIPAL UTILITIES AUTHORITY, COUNTY OF OCEAN, STATE OF NEW JERSEY, REGARDING CONDEMNATIONS FOR PHASE VII WATER EXPANSION PROJECT
