**RESOLUTION OF THE
BERKELEY TOWNSHIP MUNICIPAL UTILITIES AUTHORITY,
TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NJ
REGARDING NORTHERN BOULEVARD
PAINTING AND REHABILITATION PROJECT**

WHEREAS, United Painters, Inc., was the winning bidder on the Northern Blvd. Water Tower Painting and Rehabilitation project for the Berkeley Township Municipal Utilities Authority (hereinafter referred to as the “Authority”); and

WHEREAS, there was a Notice to Proceed, dated January 3, 2024, and the contractor initiated the project; and

WHEREAS, a voucher titled Pay Estimate #4 was presented to the Authority and CME Associates for work that was completed between June 21, 2024 through August 9, 2024; and

WHEREAS, the total construction costs associated with the voucher that was submitted was \$145,500.00; and

WHEREAS, the Authority, pursuant to agreement, is to deduct a 2% retainage or a total of \$2,910.00; and

WHEREAS, the Authority’s Engineer has reviewed the voucher and supporting documentation and has approved payment to United Painters, Inc;

NOW, THEREFORE, BE IT RESOLVED this 22nd day of August, 2024, by the Berkeley Township Municipal Utilities Authority as follows:

1. The Authority accepts the recommendation of its Engineer, CME Associates, with regard to their review of an invoice that was provided for work done on the above-referenced project from June 21, 2024 through August 9, 2024.


2. The Authority authorizes the payment to United Painters, Inc., of \$142,590.00 which represents the net amount due from the original invoice of \$145,500.00 less a retainage of \$2,910.00.
3. The Authority hereby authorizes and directs the Chairperson, Secretary and Executive Director to execute any and all necessary documents in order to implement the intent of this Resolution.

BE IT FURTHER RESOLVED that a certified copy of this Resolution shall be forwarded by the Executive Director to the following:


