Station Road Water Treatment Plant Generator:

Mr. Chiaravallo stated six bids were received for the Station Road Water Treatment Plant Generator project. The amounts ranged from \$467,000.00 to \$635,000.00. CME reviewed the bids and found all were in order with no irregularities. The Board tabled the award until the February 2025 meeting.
