Treasurer's Report:

Executive Director's Report:

Increase QPA Bid Threshold to \$53,000.00:

Mrs. Nugent requested of the Board authorization to increase the bid threshold. The state of New Jersey increased the bid threshold from \$44,000.00 to \$53,000.00. The Authority is able to authorize this increase to the bid threshold because Mrs. Nugent is certified as a QPA.

Ms. Binder stated CME submitted the documents to the DEP for the Phase VII, Contract 1 project. CME will prepare responses to the comment letters received from the engineering and environmental review sections of the DEP. The bid schedule and documents were approved.

Northern Blyd. Tank Rehabilitation:

Ms. Binder stated CME is in coordination with the Contractor and the Authority Consultant for the new camera system.

Station Road Water Treatment Plant Generator:

Ms. Binder stated the shop drawings from the contractor are under review with CME.

Old Business:

Mr. Bekiarian and Mr. McGrath attended a meeting with CME Associates to review the draft RFA for the NJDEP Coordination, Contract Separation, Bid and Construction Phase Services for Contract 1 (Area 3). Mr. Bekiarian provided the Board a summary of the project which will encompass the conversion of 99 wells to city water and include 10,000 linear feet of water main. The total project estimated cost including contingencies will be \$3,075,849.00. This committee recommends acceptance of the referenced proposal.

Mrs. Nugent stated Mr. Hale is resigning his position as of July 31, 2025. Mrs. Nugent provided an overview of the Authority's progress during Mr. Hale's tenure. Mrs. Nugent conveyed the Board's gratitude for his service and wished him well on his future endeavors.
